This tool can be used to analyze Water Main ratings and Street ratings in the community. The Water Main Rating is a composite risk score of two risk subtypes (Likelihood of Failure Risk x Consequence of Failure Risk). The Likelihood of Failure score is an evaluation of Pipe Material, Install Date, and Number of Breaks. The Consequence of Failure score is an evaluation of pipe diameter, street classification, and Accessibility. For all three risk scores, the higher the score, the more risk.
